Recently, on Father's Day, a resident member who had been through the training earlier this year, quickly noticed his wife experiencing a heart issue and immediately called 911 and administered CPR until EMTs arrived. The good news is that his wife has fully recovered from her episode and both husband and wife are so grateful of the quick service of the EMTs just across the street.

For that answer, you might want to look at your Sarasota County tax bill, paying attention to the amount for local/state School Boards. If you do the math, you will come to the simple conclusion that it's the biggest chunk of your tax bill and the school system is an investment for you. #### Hurricane lan by the Numbers

Parcels was able to obtain the following info from the City of Venice reflecting the incredible damage from Hurricane Ian:



- ✤ \$4.5 million cost of debris pick up
- \$1 million City's additional personnel cost \$750K - debris management and oversight services
- \$4 million damage claims on public property
- 300 city permit applications for building repair immediately following the storm 18 number of buildings that were destroyed
- 4,500 number of residential and commercial structures that had reportable damage
- \$72 million estimated residential structural damage
- \$20 million reportable damage to commercial structures

#### **New Laws on the Book**

Two new laws that are currently getting the most talk locally are: (1) the golf cart law requiring that anyone who drives a golf cart must be 15 with a learner's permit or 16 with a driver's permit and (2) allowing Floridians to carry concealed weapons without government issued permits. Questions have surfaced; such as does that mean that your 14-year-old grandchild who visits the Venetian can't drive your golf cart under your supervision to the swimming pool? Can you or a guest of yours carry a concealed weapon if you have dinner at the Golf Club and/or River Club? Look for future responses from both the CDD and the Golf Club Management (Heritage) on these two questions.

At the end of July, the Laurel Road Vet Clinic will move from Plaza Venezia to a new location at the strip mall. ### **PLAY BY PLAY**

#### **Commercial Development**

After an unusually long hearing, on June 16 the Venice Council voted 5-1 in favor of approving Pat Neal's proposed shopping center rezoning to be located directly across from the Venetian entrance. Council member Rachel Frank was absent for the vote. There was also a second and final reading on July 11 of the ordinance approved by City Council to re-zone 10.4 acres of open space and wetlands for use by Pat Neal's proposed shopping center. The next step which really counts is the appeal process if that is the direction determined by the POA. There is a 30-day period when the appeal must be made. Assuming the appeal is made to a circuit court, the parties to the appeal file briefs and the court holds an oral argument where the parties make their arguments to the Judge. This is much different from the City Council hearing where the public was able to testify at the hearing, plus the Council meeting was broadcasted. Note that the city of Venice is the target of the appeal, not the developer. The city can be represented by their own attorney or decide to hire outside counsel to represent them. Like any judicial hearing, there are costs to the process. Parcels, as it has done, will keep residents informed of any significant developments.

#### Laurel Road Widening

There doesn't appear to be any roadblocks associated with the widening. The Governor signed the portion of the budget bill which provides millions of dollars for the road widening. The County will soon hold another community-wide meeting on the status of this project. Regarding the traffic light at the corner of Veneto and Laurel Road, there has been no movement on the appeal of the decision by County officials to not allow a traffic light at our entrance.
