Checking with Those Who Know

Parcels sought the knowledge of experienced City leaders regarding next steps with two important northeast Venice projects:

The Shopping Center

"The Neal project still has to gain approval through the site and development plan process and is nearly ready to schedule for Planning Commission consideration in a public hearing. If approved, they will need to get construction plan approval through the Engineering Dept. as well for the horizontal infrastructure. In the meantime, they could request a clearing and grubbing permit through the Engineering Dept. which would permit them to impact the property in the upland areas. They would also need to obtain a tree permit as well. Clearing and grubbing is something any landowner can do as long as they have the required permits."

The Northeast Park on Laurel

"The Northeast Park 90% draft plans are under review and we are preparing to obtain costs for construction services. This park is shaping up to be an incredible park. Hoping that construction costs have not increased too much to support all the improvements proposed."

Valuable HRT Seminar for our Residents

Parcels believes there will be many pleased Venetian residents once they know that Venice City Council recently approved a budget designation for the hiring of additional safety service personnel (ie. fire, police) AND approved to use up to \$8 million in road impact fees for the widening of Laurel Road.

Homes, Homes and more Homes

While the traffic is not that bad, mosey down Laurel Rd. (left out of the Venetian) and on Knights Trail and Rustic Road and you will come to the conclusion that there is plenty of new home construction coming to Venice. The saying is, "If you build it, they will come." Parcels reached out to a very experienced realtor who does a lot of work in the Venetian, asking about the market inside the gates. The response was:

Many houses in the Venetian are getting to be 20 years old and need updating, thus making it difficult to secure insurance. People are looking at new construction. Because we deal mainly with cash, the interest rate is not an issue. If priced right, a house will sell quickly.

Home Owners Association (HOA) Face New Laws

HOAs in Florida have been put under the microscope and changes have been instituted. As of July 1, 2024, HOAs will be prohibited from banning common-sense parking; fining residents for leaving garbage cans out on trash day; creating rules for the inside of structures or backyards (like prohibitions against gardens or clotheslines) that can't be seen from the street, neighboring property or common area; and more. The law also mandates more transparency and accessibility on the part of the HOA officers or management companies. We are confident that our own POA will keep residents informed of significant changes.

UPCOMING ELECTIONS

The Community Association is apolitical; however, we strive to supply residents with timely and useful information. What follows is intended to inform residents about upcoming elections without any suggestion of which candidates or parties to support.

Dates to remember:

- 1. August 20, 2024 will be the next Election Day with early voting from Saturday, August 10th until Sunday, August 18th.
- 2. Voter registration/party change deadline: Monday, July 22
- 3. Deadline to request a vote-by-mail ("VBM") ballot: Thursday, August 8 @ 5pm
 - a) Check your VBM status at www.sarasotavotes.gov
 - b) VBM ballots MUST be received in the Elections office by 7pm on August 20th
 - c) VBM ballots are mailed out approximately 40 days prior to the election
 - d) If you are out of town between July 11 and August 8, VBM ballots will not be forwarded so you must change your address at the above website
 - e) Mail back the VBM ballots by August 13 or bring to any secure ballot intake station (the nearest is the Anderson Admin. Building near Jacaranda and Tamiami) between July 11 & August 20 on Mondays through Fridays from 8:30am-5pm & 8:30-4:30pm on early voting weekends: August 10-11, and August 17-18.

Elections/Primaries on August 20, 2024:

A. Sarasota School Board:

- 1. Seat 2-Karen Rose (R), incumbent vs. Liz Barker (D)
- 2. Seat 3-Tom Edwards (D), incumbent vs. Gregory Wood (R) & Thomas Babicz (R). If Edwards wins 50.1%, he is the winner, otherwise there will be a runoff of the two top candidates in November.

The League of Women Voters of Sarasota is holding a School Board Candidate Forum on Wednesday, July 17 from 5:30pm-7pm at the Jacaranda Library & live streamed on https://www.youtube.com/channelUC6N_NmJyYCClgWRpqfwppgw (registration not required).

B. Sarasota Memorial Hospital Board REPUBLICAN Primary Election:

Four of nine seats are up this year. The winner will run against the Democratic candidate & other write-in candidates in November. ONLY REGISTERED REPUBLICANS CAN VOTE IN THESE PRIMARIES

Seat 1 - Central District (OUR DISTRICT):

Incumbent Sarah Lodge (R) vs. Tanya Marie Parus (R) with the winner facing Vicki Lynn Nighswander (D) & 1 write-in candidate in November.

At-Large Seat 1:

Incumbent Sharon Wetzler DePeters (R) vs. Tamzin Rosenwasser (R) with winner facing Alan Sprintz (D) & 3 write-in candidates in November.

At-Large Seat 2:

Incumbent Kevin Cooper (R) vs. Stephen Guffanti, MD (R) vs. Kendra Becker Musante, NMD (R) in the primary with the winner facing John Lutz (D) & 1 write-in in November.

At-Large Seat 3:

Incumbent Pam Beitlich (R) vs. Mary Flynn O'Neill (R) with winner facing George Davis, MD (D) & 2 write-ins in November. All Sarasota registered voters can vote in NOVEMBER in the at-large elections & only voters living in our district, Democrat & Republican (such as those in the Venetian) can vote for this Central District seat in November from 5:30pm-7PM also at the Jacaranda Library & live-streamed on: https://youtube.com/live/6c6uHYzgcUo?feature=share

District 3:

Incumbent Neil Rainford (R) vs. Tom Knight (R), the winner to face Shari Thornton (D) & 1 (write-in) in November. The League of Women Voters will live-stream (ONLY) a Candidate Forum for the Sarasota Commission Republican Primary on Monday, July 22 from 5:30pm-6:30pm on https://www.youtube.com/channel/UC6N_NmJyYCClgWRpqfwppgw

D. Democratic primaries: (only Democrats can vote in these):

US Senate: the winner will face incumbent Rick Scott (R) in November:

US Congress: Florida District 17 the winner will face incumbent Greg Steube (R) in November:

- 1. Manny Lopez
- 2. Matthew Montavon
