HELPFUL ADVICE

The Waver

The Venice Fire Department recently provided CPR training for three full classes of residents plus a special session for staff members from the Golf Club and River Club. The training was excellent. One of the bits of advice they provided was very simple and helpful if faced with an emergency at your home, workplace or even on the tennis or golf course. If you have an extra person, designate him/her as the **"waver"**. The role of the "waver" is to go outside and "wave" down the emergency vehicle directing them to the location of the person in distress. If you do not have a waver available and you are in your home, turn on as many outside lights as you can and leave the front door open. In most emergency situations, time is of the essence. Having the "waver" is a technique which will quickly direct the first responder to the exact location of the emergency.

WE'RE PAYING ATTENTION

Commercial Application at Laurel and Jacaranda

The application for the Commercial Shopping Center was denied by the Planning Commission, 4-3, at their hearing on March 21st. The final decision makers (unless the decision is appealed) are those who sit on Venice City Council. It is expected that the issue will move to Council probably in May; however, nothing is certain until it is placed on the agenda, which usually comes out the Thursday prior to the Council meeting. Regular council meetings take place the second and fourth Tuesdays of the month. There will be two separate hearings on the matter using the quasi-judicial process. As with all council meetings, instructions will be provided as to the nature of public comments. Residents are encouraged to attend or view the hearings on the video session provided by the city. Unless the decision is appealed to the courts, this is the final step of the process for approval/disapproval of the application. The city is working on an informative document that will explain the process in more details.

Laurel Road Widening and More

This county project is moving forward with attention being directed to Tallahassee for additional funds. Related to this project, and in the bigger picture of moving traffic away from heavily traveled I-75, Sarasota County has made the recent decision to connect Lorraine Road to Knights Trail Road. This plan, once completed, would enable you to go down a four lane Laurel Road, turn right on Knights Trail and travel on the newly constructed Lorraine Road to get to Sarasota around Clark Road. This new connection will handle traffic, both northbound and southbound.

It's Not ALL About Over-Development

Although rapid development in this area receives much of our attention, the VGRC is fortunate to be adjacent to several nature preserves just north of us, and some residents have made the effort to learn about and explore these beautiful, natural places. The county has designated over 120,000 acres of conservation lands, and some nearby tracts are part of a major effort to restore the water quality of Dona Bay by transporting runoff underground for better natural filtration. These preserves provide a natural buffer from development to our north and offer many recreational opportunities. 

GETTING PREPARED FOR THE "SEASON"

The 2023 Hurricane season is rapidly approaching and lest we are tempted to scoff at a reminder to be prepared, let us remember Hurricane Ian. September 28, 2022, is a date that many of us will remember; it is a day that we learned that Venice can be vulnerable to a hurricane when Hurricane Ian (which on Sept. 27th was predicted to make landfall at Venice as a category 3 hurricane, but turned further south) battered our area with its outer winds. Yes, Venice can be impacted by a direct or indirect hurricane landfall and, yes, we should take hurricane preparation seriously.



Hurricane season begins June 1st and ends the last day of November. The Community Association's Hurricane Response Team (HRT) will once again begin training and preparing for its role in hurricane preparation and response. The team will be accepting applications from those who would like to be part of the team that proved its worthiness when the members were called out to serve prior to -- and following -- Hurricane lan's visit to our community. A link to the applications will be provided through an email that will be sent out in April with a description and duties of the different teams. A community-wide hurricane preparation meeting sponsored by the HRT and the Community Association will also be held in May. "Facing the Challenges Ahead"

Thanks to the many residents who showed up at the 2023 Town Hall meeting on March 20th sponsored by the Community Association. We appreciate the participation of all our speakers who provided very up to date information. Also, there were a number of guests including five of the seven council members who saw the level of interest Venetian residents have for their community.....we appreciate their attendance. Below are a series of articles that relate to the various presentations.

Homeowner Insurance

One of the topics at the Town Hall Meeting was the impact of Hurricane Ian on one's homeowner's insurance. The speaker was David Joyner, a highly respected insurance agent in Venice. Attached is an outline of his very helpful presentation.

Sarasota Memorial Update

Since opening its doors in November of 2021, Sarasota Memorial Hospital-Venice ("SMH-Venice") has played a vital role in the community helping to meet the rapidly growing demand for high-quality health care in the south Sarasota County region. To date, the 110-bed hospital has performed more than 7,500 surgeries, treated 50,000 Emergency Room patients and 17,500 in-patients, and delivered more than 300

babies — including two sets of twins! As patient volumes continue to grow, SMH-Venice is committed to expanding its staff, services and size to improve

access to care. The campus now has more than 1,250 employees, 1,100 medical staff members and 220 volunteers. The investment in growth extends beyond the walls of the original facility. Construction is proceeding full speed ahead on a five-story new patient care

tower that will nearly double the campus' capacity. When complete in 2024, the new wing will add 102 beds, bringing the total number of private patient suites available at the campus to 212. The expansion will prompt the addition of a traffic light at the

intersection of Pinebrook Road and Healthcare Way, which is the main entrance to the campus. The hospital also is hastening plans to double the size of its Emergency Care Center and Surgical Department, with construction slated for completion in 2024. For the interim, the facility has reconfigured its space and patient flow and hired more staff to enhance efficiency and capacity. When necessary, patients can be transferred to

the SMH-Sarasota Campus. The health system also has embarked on longer-term projects to expand access to care throughout the fast-growing south county community. Plans are moving forward to open a new hospital on Sumter Boulevard in North Port, as well as a new medical campus in Wellen Park. Sarasota Memorial also is looking at opportunities to bring a new freestanding Emergency Room to Venice Island and a new Urgent

Care Center to North Port. In the meantime, the health system has continued to step up to meet health needs despite several unprecedented challenges, including the abrupt closure of ShorePoint Venice Hospital last fall, followed by the devastation of Hurricane Ian. When ShorePoint gave just a few weeks' notice that its 312-bed hospital on Venice Island would close. SMH-Venice rapidly repurposed clinical space to add more triage and treatment areas and brought in additional physicians and staff. Ultimately, the health system hired more than 100 displaced ShorePoint employees. The Venice campus saw a huge influx of patients — as many as 250 a day — in the immediate aftermath of the storm. State, federal and local officials helped meet the challenge. A federal Disaster Medical Assistance Team was deployed to the hospital to set up an emergency tent facility that helped manage the surge.

What's the Number One Problem Sarasota County is facing?

At the Town Hall Meeting, both County and City Police officials noted that the number one problem they see for the city/county is ... traffic. Think of all the problems that the police face in their role...but in growing Sarasota County, all of them really don't count as much as when cars get on the road.

Growing and Growing and Growing and

The map attached at the end of Parcels was developed by the Community Association and distributed at the Town Hall Meeting. After looking at it, especially the key in the bottom left of the map, one could conclude that it captures the growth and development in northeast Venice. If the growth and development take place per the map, it's realistic to believe it has implications to healthcare, school capacity, shopping and shopping experiences. local traffic and safety services.

Hurricane Ian & the Deteriorating FL Home Insurance Market

Hurricane Ian - Large Storm / Widespread Damage

- Although a massive storm, wind losses largely transferred to (paid by) reinsurance companies; flood losses largely assumed under separate flood policies (FEMA)
- · However, a "man made" storm existed long before Hurricane Ian, caused by:
 - Rampant litigation Florida represents nearly 10% of all home insurance claims in the US, but accounts for nearly 80% of all home insurance litigation!
 - o Over 70% of home insurance claims payouts went directly to attorneys
 - Assignment of Benefits ("AOB") combined with litigation incentives led to pervasive "free roof" schemes
- The result of this "man made" storm?
 - o Massive net losses and need for fresh capital infusions into home insurance companies
 - Approx. dozen company insolvencies; thousands of policy non-renewals; limited markets open for new business
 - Substantial rate increases! Florida average home insurance premium approx \$4,300 (3x national average); Sarasota County nearly \$2,700!
- Good news! Hurricane Ian illuminated these issues and "transformational" legislation was passed in Dec. 2022 to eliminate the "man made" storm issues

What is to Come?

- While legislation was meaningful, the impact will take much longer to realize at least 18-24 months. Rate filings with state regulators are based upon historical information, so results must be present to demonstrate rate relief.
- Hurricane Ian doesn't help with this timeline, as there's debate as to whether legislative changes apply to Ian claims and this will get fought in court
- Biggest remaining impact: REINSURANCE ("insurance for insurance companies" typically involving catastrophic risks e.g., hurricane)
 - Reinsurers hit hard by Ian (and waiting to see the "full" impact over coming year+) along with other worldwide disasters
 - Less investment into reinsurers; waiting to see the impact of legislative changes all resulting in less coverage/capacity offered, strict payment terms, and rates increasing at least 50% on average
- In Summary: things will get worse before they get better more steep rate increases are coming and fewer companies are offering new policies. New companies will eventually enter the market and, hopefully with a quieter storm season, we'll begin seeing some stabilization in 2024
