### Recognizing Our Supporters

## NEAR AND FAR

### In this corner ...the developer ...in the other corner, the challenger

On January 26th, Roger Clark, Director of the Venice Planning and Zoning department, gave a very informative presentation to residents attending the VGRCCA sponsored seminar. He explained the developer approval process in detail, showing the multitude of steps required before the first shovel of dirt is turned. Mr. Clark commented on the state's increasing efforts to limit local control, most recently though a new state law, SB 180, which will retract impact fees and regulations for development to where they were in August of 2024. Cities and counties are pushing back on this law, saying it will allow even more unplanned growth. He stated that, per state law, Venice cannot deny a developer's plan if it complies with the Comprehensive Plan, Land Development Regulations, and the Binding Master Plan. It can only be rejected if there is competent and substantial evidence to deny it. The Bert Harris Private Property Rights Protection Act of 2011 provides relief to owners of "inordinate burdens." This act was the primary reason why local homeowners and residents were unable to prevent the development of the Milano commercial project across the road from our entrance. Mr. Clark further stated that the high median house price in Venice has made it challenging for many individuals to purchase a single-family home, which is the primary reason behind the construction of mixed-use family dwelling housing along Laurel Road and in other areas. Mixed-use developments offer economic benefits to governments, consumers, and developers, he said.

## Food Lovers

The Jewish Food Festival, scheduled for **February 15th from 10 am - 3 pm**, is a tradition that food lovers flock to. If you enjoy corn beef sandwiches, stuffed cabbage, kugel, chopped liver and more, take yourself -- and possibly your "Tums." To get to the festival take Jacaranda, turn right on Edmondson and take the first left on to Auburn. About halfway down you will see the festival on the left. Parking and admission is free. Also included are vendors, free entertainment and the annual jewelry sales.

And if you didn't have enough calories.

Get to the **37th Annual Venice Italian Feast and Carnival on Feb 19-22** at the Venice Airport. Parking is free but admission varies depending on the day you attend. Live music; entertainment; rides; lots of entertainment; and of course, that wonderful Mama Mia Italian food.

## Honoring the Man who Started It All

As part of the City of Venice's Centennial celebration, the Venice Area Historical Society (VAHS) and Venice Area Beautification Inc. (VABI) have partnered to commission a statue honoring John Nolen, one of America's most distinguished urban planners. Nolen was commissioned in 1925 to design what was then a small Gulf Coast town - Venice, FL. His design is widely recognized for its thoughtful parks, landscaped streets, and traditional neighborhood planning that still define the character of Venice today. The unveiling of the John Nolen statue will take place on **Wednesday, Feb. 18** in Centennial Park at the corner of Nokomis Ave. N. and W. Venice Ave. The Venice High School Marching Band will perform at 9:00 am, followed by remarks and the statue unveiling at 9:30 am.

### Do I Need Flood Insurance?

Flooding is the most common and costly natural disaster according to FEMA. They also indicate that flood insurance can be the difference between recovery and financial devastation. Most homeowners' insurance policies do not cover damage arising from flooding. Unfortunately, any home can be vulnerable to flooding even if it is not within a high-risk flood zone. FEMA estimates that almost 1/3 of flood insurance claims come from OUTSIDE high-risk flood areas.

To assess your property's risk level and to make a personal decision regarding flood insurance, please visit the FEMA Flood Map Service Center (MSC) and Search by Address and/or consult your insurance agent prior to the rainy season beginning in Florida.

## Approaching your Four-legged Friend

There are several dogs in this community which add to the quality of life for owners. Parcels sought out the guidance of the American Kennel Club in helping you and perhaps your (grand) children regarding how to approach a dog once you get permission from the owner. To make yourself appear as friendly as possible, turn your body slightly to the side and look at the dog with your peripheral vision. In dog language, head-on approaches and direct eye contact are threatening, so avoid them if possible. You can also kneel to the dog's level, so you aren't looming overhead. However, if you are in any way uncertain about the dog, stay standing. After all, kneeling will put your face at bite level. Dogs don't shake hands like people do; they use their nose to say hello. So, hold your hand in a fist so they can approach and sniff if they choose. Don't thrust your hand at the dog. They can smell you just fine from a distance, and the sudden movement could startle them. ## Scam alert: The "Federal Jury Summons" Threat

A recent incident involving a local resident serves as a chilling reminder of how sophisticated—and aggressive—phone scams have become. What began as a quiet drive between two friends quickly escalated into a high-pressure psychological ordeal designed to extort thousands of dollars.

## The Setup: Exploiting Civic Duty

The call originated from an unknown number. The caller identified himself as a **U.S. Marshal** and claimed the resident had ignored a federal jury summons in Tampa. To make the claim more believable, the "officer" provided a badge number and the name of a real federal judge. Crucially, the victim had just completed jury duty in Sarasota. The scammers exploited this recent, stressful experience to create a sense of panic.

## The Psychological Trap

The scammers used a "tag-team" approach, with a second, more aggressive "superior" joining the call. They utilized several high-pressure tactics to keep the victim off-balance:

- Complete Personal Profiles: They possessed the victim's full legal name (including middle and maiden names) and her exact home address, making the threat feel legitimate.
- Isolation: They forbade her from speaking to anyone else or muting the call, threatening that any interference - even from the friend in the car—would lead to an immediate arrest.
- Emotional Manipulation: They texted "official" documents, including a fake arrest warrant and a "gag order". They forced her to read the arrest documents aloud, a tactic designed to maximize her distress and perhaps record her voice for future fraud.

## The Financial Demand

The "officer" claimed a judge had set a fine of \$45,000, demanding a cash payment of \$9,000 that very day to avoid incarceration. Initially, they instructed her to go to a courthouse to "verify her signature" but quickly pivoted, directing her toward a bank and a third-party payment location.

## The "Tells" of a Scam

Despite the elaborate setup, there were several red flags that became clear once the victim was away from the pressure of the call:

- Unprofessional Conduct: One of the "officers" used profanity (an "F-bomb") when the friend tried to intervene.
- Inaccurate Details: The Sarasota address they provided for the "courthouse" was a building used for Teen Court.
- Third-Party Payments: Law enforcement will never ask for payment via third-party locations, gift cards, or wire transfers.
- Isolation Tactics: Real authorities will not demand that you remain on the phone or prevent you from consulting a lawyer or family member.

## What to Do if You Receive This Call

If you receive a call from someone claiming to be law enforcement or a court official:

1. Hang Up Immediately: Do not engage. If the call is legitimate, you can verify it through official channels.
2. Verify Independently: Call the Clerk of the Court or the local Sheriff's Office using a verified number from their official website, not a number provided by the caller.
3. Protect Your Info: Never confirm banking details or personal identifiers over the phone to an unsolicited caller.
4. Report It: Notify the local police and the Federal Trade Commission (FTC).

## FINAL THOUGHTS

### Safe Travel

The CDD has been pushing for years and years about the importance of traffic safety in our community. Parcels couldn't agree more. In preparation for this article, Parcels spent a day paying close attention to safety concerns. In this short time, Parcels saw cars going through stop signs; a bicyclist not paying attention as she was both pedaling and talking on her phone; speeding cars and trucks by both residents and contractors; golf carts rolling through the stop signs heading off to hole 6; and walkers taking their life in their hands by walking early in the morning when drivers are dealing with the bright sun in the east. Since this community began, we have been fortunate in not having any serious accidents. But the potential is there and we must realize that safety is of great importance to every resident in our community....and primarily an individual responsibility.




