Cash Position

The cash position of the Organization was **\$62,543.19** as of April 30, 2026.

Year to Date

For the 3 months ending on April 30, 2026, the VR&RC Community Association, had revenue of **\$11,003.51** and expenses of **\$9,643.90** leaving a profit of **\$1,359.61**.

March and April 2026 yielded losses of \$1235 and \$1520 respectively.

Interest income **\$10.12** for the month.

Money Market Annual Percentage Yield was **1.51%** as of April 30, 2026.

Notes

\$40,000 was moved to a CD on November 13, 2025, at 2.8%. Interest income on this money will not be realized until maturity date of June 13, 2026.

A second, 13-month CD was purchased for \$10,000 from the Money Market account on March 30, 2026, at 2.65%. Interest income on this money will not be realized until maturity date of April 30, 2027.

An additional premium of \$860.97 was incurred as the final reconciliation of membership for our GL/Umbrella Insurance policy. That adjustment was made to our monthly prepaid insurance amortization. A partial refund will be issued for our D&O insurance which will result in an additional adjustment lowering our monthly amortization. Refund of 767.70 was received. Monthly Insurance Expense will be reduced to \$1,055.87 beginning June 1.

The membership revenue is now being recorded on a "cash basis". Adjustments have been made to prior periods and years for comparison purposes.

The HRT donations are being accounted for on the Statement of Financial Position as a liability as these are restricted for HRT use only.
